Wednesday, May 15<sup>th</sup>, Sandy Leong, 'The Bishops Finger'

Sandy is an historian, published author and a professional speaker. Sandy will give a lighthearted look at the history of British Pubs. The British public house started life as a Roman Wine Bar and dates back over 2000 years. Ale was central to the Anglo-Saxon sense of community, the place to get drink, often using a brush as a sign. An amusing evening is assured.

**Little Bowden Information Leaflets** – Back in 2001, the society, with sponsorship, published various leaflets about Little Bowden, which included various people, guided walks, and buildings of interest. As much has changed over the past 20 years, these leaflets have now been updated and reprinted. They are on sale at £3.00 for the three. These are on sale at Monthly Meetings or from Phil Baildon.



As announced at the AGM, Market Harborough's first Neighbourhood Forum has now been well established in Little Bowden – This gives residents more of a say in planning and land use in their community, as well as tackling issues such as flooding, traffic, and the care of green spaces.

Six of our Society members are on the Forum Committee, and they are working with other Forum members to develop a 'neighbourhood priorities statement' with a longer-term view of writing a Neighbourhood Plan.

The Transport Group are already lobbying Central Government, LCC and HDC to try to avert the threat by Leicestershire County Council to cut subsidies for local bus services, plus planning applications within Little Bowden.
